


# HOW TO COMPLETE A BH SCORESHEET

# PLEASE FOLLOW THE STEP BY STEP GUIDE BELOW, TO HELP YOU COMPLETE THE FORM.

Steps 1 – 3 can be completed pre-trial

Step 4 - 6 are to be completed post-trial

## STEP 1. ENTER THE EVENT DETAILS



STEP 2. ENTER INFORMATION PROVIDED FROM THE EVENT ENTRY FORM

## STEP 3. HOW MANY PAGES FOR THIS PARTICULAR TEST

Each scoresheet can hold 6 entries, so if you have less than 6 entries you would complete one sheet and mark number of pages as follows:

PAGE \_1\_\_\_OF \_\_1\_\_\_

If you have more than 6 entries, so for example 8 doing the same exam, you would complete two sheets and mark, as follows:

Sheet number 1:	PAGE _1OF2
Sheet number 2:	PAGE _2OF2

#### **STEP 4. ENTER THE RESULTS OF THE TEST**

Please remember the test is in 3 parts, a written exam (only applicable if a competitor has never completed a BH before) Part A is the obedience, dogs are required to reach the required 70% before they are taken for examination in Part B which is the Traffic portion of the test.

If a dog passes all parts, the result should be recorded as "PASS" if they don't pass all parts it will be recorded as a "FAIL".
